

Terms and conditions of the promotional offer for new customers: “Get a credit of €50 for purchases of €50 or more with the Banco Sabadell BS Debit Card”

1. Banco de Sabadell, S.A. (hereinafter, the Bank) is running a special offer aimed at natural persons residing in Spain who, during the promotion period, registered as customers of the Bank by opening the Sabadell Online Account¹ for individual use.

Based on this promotion they can receive:

- **A one-off credit of €50² gross when making a purchase of €50 or more or several purchases totalling €50 or more with the Banco Sabadell BS Debit Card linked to your Sabadell Online Account between 1 April and 30 June 2024.**

All in accordance with the terms and conditions of this promotion.

Participation in the promotion entails acceptance of these terms and conditions.

2. **Period of the promotion: from 1 April to 2 May 2024**, both inclusive.

3. Terms and conditions of the promotion

A. For purchases totalling €50 or more

- A one-off credit of €50² gross (**€42.02 is credited to your account**) when you make one or more purchases totalling €50 or more with the Banco Sabadell BS Debit Card linked to your Sabadell Online Account between 1 April and 30 June 2024. Your account will be credited on 23 July 2024.
- “Purchase” is understood to mean any transaction made with the debit card to acquire a good or pay for a service, expressly excluding the payment of financing transactions, even though they may be settled as a “purchase”.
- To be entitled to receive this credit of €50² gross (**credit of €42.02**), the Online Sabadell Account must be active on the day the credit is made.
- Any cancelled operations will not be taken into account for the offer. Similarly, the incentive will not be credited if there is a refund of the card payment for which the promotion applies.

4. The Bank reserves the right to amend or cancel the promotion, as well as to change the date of the payment of the incentive, which will be duly reported, and to exclude from the payment any person it deems ineligible or who has acted in bad faith.

 - Be over 18.
 - Be a new Banco Sabadell customer.
 - Reside and pay taxes in Spain.
 - Not hold U.S. citizenship.
 - Not have held any position of public office in the last 2 years.
2. The net amount of the €50 credit for purchases of €50 or more is €42.02. In accordance with personal income tax regulations, this amount is considered as securities income from movable capital subject to withholding tax at the currently applicable rate of 19%.
